

WRB30104 - CERTIFICATE III IN BEAUTY SERVICES

The Certificate III in Beauty Services enables students to work in beauty or hairdressing salons with a selection of beauty, artificial nail and make-up skills. Beauty treatment skills include manicures, pedicures, lash and brow treatments, waxing, bleaching and science of the skin. The course is structured so that students complete the 14 core units and then they choose their electives from option 1, option 2 or option 3. Option one covers all aspects of skilful application of make-up for every day, special events, such as weddings, and glamour events. Special attention is given to make-up required for photographic purposes and skilful application for remedial and camouflage make-up. Option 2 covers all aspects of nail technology, including sculptured nails, extension tips, overlays, French acrylic application and gel nails. It also includes 3 retail units and ear piercing. Option 3 covers all aspects of the skilful application of make-up as well as all aspects of nail technology.

Traineeship Course

A traineeship involves a student completing the qualification with both a beauty therapy salon and a registered training organisation. The trainee and their employer sign a contract to work together. The employer undertakes to train the trainee in all possible aspects of the qualification. The employer and trainee then engage a registered training organisation and negotiate a training plan to complete training for the units of the competency that the employer is unable to complete.

The Queensland School of Beauty offers theory lessons for trainees and any practical training that is required. All theory examinations and practical observations will be completed by the Queensland School of Beauty to ensure competence in the units of the qualification. Once the trainee is deemed competent in all units they will be issued with a Certificate III in Beauty Services.

Students can also start a traineeship while they are at school. Please note this course is competency based therefore the duration may vary. It can take anywhere between 1-4 years to complete.

Theory component: Students are tutored on theory lessons which are completed externally
